




**JOINT MOTION TO DIRECT THE PREBLE COUNTY CLERK TO
INCLUDE THE PRESENTENCE INVESTIGATION REPORT IN THE RECORD IT
SUBMITS TO THIS COURT,
TO DIRECT THE PREBLE COUNTY CLERK TO RETAIN A COPY OF THE REPORT,
AND TO PERMIT COUNSEL FOR BOTH SIDES
TO VIEW BUT NOT COPY THE DOCUMENT**

The parties jointly ask this Court to direct the Preble County Clerk to include a sealed copy of the presentence investigation report ("PSI") in the record it submits to this Court. Counsel has confirmed that the report exists and that it was part of the record below. As a result, the PSI is one of the "original papers" of this case and is therefore part of the record that should be submitted under S.Ct.Prac.R. 15.01(A)(1)(a). But clerks typically do not forward a copy of the PSI unless specifically directed to do so, and counsel has confirmed that the lower court clerk in this case will not forward the PSI unless specifically directed to do so. Further, this Court needs the report to fully consider this case because it involves a sentencing matter.

The parties also ask this Court to direct the Preble County Clerk to retain a copy of the PSI so that counsel for the State may view the document without traveling to Columbus simply for that task. Finally, the parties ask that counsel for each side be permitted to view, but not copy, the document at either the Preble County Clerk's Office or at this Court's Clerk's Office.


