


Notice of Appeal of Appellant Lamont Baker


Appellant Lamont Baker hereby gives notice of his appeal to the Supreme Court of Ohio from the judgment of the Hamilton County Court of Appeals, First Appellate District, entered in the Court of Appeals case no. C-130037 on August 28, 2013..

This case involves whether the indictment omitted the correct information to properly inform Baker that he was charged with violation of a protection order when the indictment did not properly state the case in which the protection order was entered against Baker.

The First District Court of Appeals erred by ruling that the indictment was proper and that the Court of Common Pleas had subject matter jurisdiction of Baker to proceed with the prosecution.

The indictment did not include the specific protection order that Baker violated. By ruling that the indictment was proper, the court of appeals denied Baker's constitutional right to Due Process under the Fifth and Fourteenth Amendments of the United States Constitution and Article IV, Section 3(B)(2) of the Ohio Constitution.


