

MOTION TO ENLARGE TIME TO FILE TRANSCRIPT




Being duly sworn, Leanne Haswell, says as follows:

1. I am the Official Court Reporter in *State of Ohio v. Steven E. Cepec*, Case No. 10 CR 0588, Ohio Supreme Court Case No. 13-0915. The length of the transcript is extensive. Presently, the transcript is due in the Ohio Supreme Court on October 15, 2013;
