



CLAIM DETERMINATION ENTRY

In Re Application of Hossam Abdelfattah v. Eva Catherine Gildee
Claim Number 12-0108

This cause came on for hearing before the Board of Commissioners of the Clients' Security Fund this 6th day of September 2013 on the application of Hossam Abdelfattah alleging a loss in the amount of \$15,271.5, caused by dishonest conduct of an attorney duly licensed to practice in the State of Ohio

The Commissioners of the Clients' Security Fund of Ohio find that:

- a) An attorney client relationship did exist between the claimant and Eva Catherine Gildee.
- b) The claimant suffered a loss of \$11,290.98 on or about April 14, 2012.

The Commissioners further find that the dishonest conduct consisted of fiduciary theft, and that the following disciplinary proceedings were taken:

Suspended For Term on 12/5/2012

The Commissioners further find that the claimant took affirmative action against the attorney within one year of becoming aware of the loss; and that there is no insurance or bond which will benefit the claimant; and that said claimant is not a spouse, close relative, partner, insurer or bonding company, nor a governmental unit.

Therefore the Commissioners of the Clients' Security Fund do hereby determine that the claim of Hossam Abdelfattah is eligible for reimbursement in the amount of \$11,290.98.

Payment of said amount is conditioned upon claimant complying with the subrogation assignment and other requirements of Sec. 6 of GOV. Rule VIII of the Ohio Supreme Court.
