



NOTICE OF FINAL APPEALABLE ORDER

This action was referred to Magistrate Thompson to conduct a damages hearing due to the Defendant's default, which hearing was conducted on July 12, 2012. Magistrate Thompson issued a Decision on August 31, 2012, and awarded damages to the Plaintiff Clayton Rivers and against the Defendant Robert C. Cordrick, and the Defendant Cordrick, Roston & Co., LPA, in the amount of \$35,368.51, plus court costs.

As no objections have been filed, and as no error of law appears on the face of the Magistrate's Decision, it is adopted by the Court as its own pursuant to Civ. R. 53(D)(4)(a). Accordingly, **JUDGMENT** is hereby entered in favor of the Plaintiff Clayton Rivers, and against the Defendant Robert C. Cordrick, and the Defendant Cordrick, Roston & Co., LPA, in the amount of \$35,368.51, plus post-judgment interest at the statutory rate.

Costs to the Defendants Robert C. Cordrick and Cordrick, Roston & Co., LPA. Pursuant to Civ. R. 58(B), the Clerk of Courts is hereby directed to serve upon all parties notice and the date of this judgment.
