

REQUEST TO BEGIN 60-DAY SUSPENSION JANUARY 30, 2014**


On January 17, 2014, respondent filed a pleading entitled, “Notice of Writ Denial and Request to Begin 60-Day Suspension January 30, 2014.” By its title, it is clear respondent is abandoning his argument against imposition of the 60-day suspension, which he made in response to this Court’s order to show cause. In his most recent filing, respondent states, “Respondent has spoken to the Hon. Joseph Caligiuri and does not believe he will object to this request.” While it is true that relator has no objection to this Court imposing the 60-day reciprocal suspension, relator informed respondent that this Court—and this Court alone—controls the effective date of any suspension and that relator has no input in that determination.

CONCLUSION

Relator respectfully requests this Court impose reciprocal discipline and suspend respondent from the practice of law for 60 days.


