CLAIM DETERMINATION ENTRY

In Re Application of Heather J. Monnier v. Curtis Donald Britt
Claim Number 12-0167

This cause came on for hearing before the Board of Commissioners of the Clients' Security Fund this 6th day of December 2013 on the application of Heather J. Monnier alleging a loss in the amount of \$1,299, caused by dishonest conduct of an attorney duly licensed to practice in the State of Ohio

The Commissioners of the Clients' Security Fund of Ohio find that:

- a) An attorney client relationship did exist between the claimant and Curtis Donald Britt.
- b) The claimant suffered a loss of \$1,299 on or about January, 2011.

The Commissioners further find that the dishonest conduct consisted of theft of unearned fees, and that the following disciplinary proceedings were taken:

Suspended Indefinitely on 10/3/2012

The Commissioners further find that the claimant took affirmative action against the attorney within one year of becoming aware of the loss; and that there is no insurance or bond which will benefit the claimant; and that said claimant is not a spouse, close relative, partner, insurer or bonding company, nor a governmental unit.

Therefore the Commissioners of the Clients' Security Fund do hereby determine that the claim of Heather J. Monnier is eligible for reimbursement in the amount of \$1,299, payable to Ronald Monnier.

Payment of said amount is conditioned upon claimant complying with the subrogation assignment and other requirements of Sec. 6 of GOV. Rule VIII of the Ohio Supreme Court.
