
STIPULATION TO AN EXTENSION OF TIME TO FILE APPELLEE'S BRIEF

The parties, pursuant to S.Ct.Prac.R. 14.3(B)(2), stipulate to an extension of time for the Appellee to file her merit brief.



It is so stipulated.




