**RESPONSE OF AMICUS CURIAE ATTORNEY GENERAL MICHAEL DEWINE TO
RELATORS WOODROW L. FOX, SR.'S AND WOODY FOX BAILBONDS, LLC'S
MOTION FOR VARIATION OF TIME FOR ORAL ARGUMENT**

On February 18, 2014, Relators Woodrow L. Fox, Sr. and Woody Fox Bail Bonds, LLC, filed a motion to extend the argument time for relators in each of these two consolidated cases by five minutes, for a total of 25 minutes of argument time for the relators. The movants also stated their belief that counsel for amicus curiae Attorney General Michael DeWine will only be addressing the "2013 case" at oral argument.

Attorney General DeWine does not oppose the movants' request for additional argument time, but requests that if the motion is granted, respondents also be granted additional time such that the total time allotted to relators (and any amici supporting the relators) is equal to the total time allotted to respondents (and their amicus). Finally, as the "2012 case" and the "2013 case" have been consolidated, counsel for amicus curiae Attorney General DeWine will be prepared to address both cases, which present the same legal issues.
