

Petitioner, the Village of Lodi, and Respondents, Sunset Estate Properties, LLC and Meadowview Village, Inc., pursuant to a stipulation of the parties hereby respectfully request that the Court extend the time for both parties to file their merit briefs by twenty days, as provided in S.Ct.Prac.R. 3.03(B)(2)(a). Rule 3.03(B)(2) states that “parties may stipulate to extensions of time to file merit briefs” and that “[e]ach party may obtain in a case only one stipulated extension of time not to exceed twenty days.” Neither party has received any prior extensions of filing deadlines. The parties have stipulated to an extension of twenty days for Petitioner to file its opening merits brief and an extension of twenty days for Respondents to file their responsive merits brief.

At present, Petitioner’s opening merits brief is due May 5, 2014. According to this stipulation, the new deadline for Petitioner to file its opening brief is May 27, 2014. Under S.Ct.Prac.R. 16.03(A)(2), Respondents are given thirty days after the opening brief is filed to file their merits brief in response. Assuming Petitioner files its opening brief on May 27, 2013 (and not before), Respondents’ merits brief would typically be due June 26, 2014. With the agreed extension, Respondents merits brief is instead due on July 16, 2014.
