I certify that I proceeded 'in forma pauper' in the lower court(s) and that the fact and status of my patent poverty has not changed since the conclusion of those proceedings.

I certify that I believe that I am entitled to a grant of the relief heretofore requested by reason of my clear and patent poverty and that this appeal is taken in good faith on substantive grounds for relief accordingly.


