





**Notice of Appeal of Appellant Schuyler Smith**

Appellant Schuyler Smith hereby gives notice of appeal to the Supreme Court of Ohio from the judgment of the Butler County Court of Appeals, Twelfth District, entered in Court of Appeals case No. CA 2013-12-0237 on December 17, 2013.

Three Judges, Pat DeWine, Patrick F. Fischer, and Sylvia S. Hendon of the First District, Hamilton County Court of Appeals were assigned by Chief Justice of Ohio Supreme Court, Maureen O'Connor to the Twelfth District, Butler County Court of Appeals to review case No. CA 2013-12-0237. A brief was submitted to the Twelfth District, Butler County Court of Appeals on February 7<sup>th</sup>, 2014.
