NOW COMES, Plaintiffs, MICHAEL BRICE KELLER and KELLER LAW OFFICE LLC, by and through counsel, MICHAEL BRICE KELLER.

1. Keller Law Office and Michael Brice Keller have come into knowledge of transgressions, improprieties or other anomalies in the administration of Justice, to wit: Criminal Prosecutions.

2. The Knowledge, concerns or other reporting, has gone without remedy and as an officer of the court, Michael Brice Keller does so present this report to the Court of last resort in his home state, consistant with his oath of office.

3. The state of criminal prosecutions in the State of Ohio is approaching a situation of collapse. This assessment is based on economic theory, scientific data and personal experience in law enforcement.
4. Inaction by the Supreme Court of Ohio in this matter is likely to have devastating consequences to the future of our self-regulated profession.

Keller Law Office and Michael Brice Keller prays that the Supreme Court of Ohio shall appoint Keller Law Office as special Prosecutor to investigate and determine whether Criminal Liability may be present on the part of any of the named or unnamed actors, including the Governor and Attorney General of the State of Ohio.

With Specificity, Keller Law Office LLC and Michael Brice Keller Pray for the following relief on behalf of the Citizenry of the Great State of Ohio.

1. Keller Law Office LLC shall be appointed as Special Prosecutor to the Supreme Court of Ohio, and conduct an investigation whereby, the various courts (sample Pool) shall make available Court Reports concerning the numbers of cases and their various dispositions, including additional information as required for adequate assessment.

5. Keller Law Office LLC shall be compensated for services rendered and allocated limited resources in the way of legal assistants, paralegals and/or other administrative personell.


