


SUPPLEMENT TO APPLICATION

Now comes Leo J. Talikka whose attorney registration number is 0006613, by and through his counsel, Koblentz & Penvose, LLC, and hereby respectfully supplements his application to this Honorable Court for his reinstatement to the practice of law.


In response to the letter received from the Office of the Clerk filed June 23, 2014, Mr. Talikka states that he paid all statutory interest payments to the clients prior to the filing of his application for reinstatement as required by the suspension order of March 20, 2013. Evidence of these payments is contained in his Response to Show Cause Order filed on May 20, 2013 to which Mr. Talikka attached his affidavit of compliance (which was previously filed on April 19, 2013 but not accepted for failure to include a certificate of service). In paragraphs 8, 9 and 10 of that affidavit, Mr. Talikka testifies to the efforts he undertook to make interest payments to his former clients as ordered by the suspension order, that the statutory interest payments were made, and further authenticates the documents attached to his affidavit evidencing those statutory interest payments. The attachments to the affidavit were not scanned and placed on the court's electronic docket, but are believed to be included in the record. Those documents attached to the affidavit include copies of checks for the interest payments to Mr. Homkes, Ms. Cantrall and Mr. Ingram as well as the letters and U.S. Certified Mail return receipt green cards evidencing delivery confirmation to Ms. Cantrall and Mr. Ingram. The letter sent via U.S. Certified Mail to Mr. Homkes was returned as the time for forwarding to Mr. Homkes' unknown, new address had expired.

However, not included in his affidavit as it was secured approximately five (5) days after the initial filing of the affidavit, is the notarized, signed receipt by Mr. Homkes

acknowledging receipt of the statutory interest payment delivered to him by Mr. Talikka.
A copy of that notarized receipt is attached hereto as Exhibit "A".

WHEREFORE, Applicant having met all of the requirements set forth by this Honorable Court under Gov. Bar Rule V, Sec. 10 (A)(1) Applicant, Leo Johnny Talikka, hereby prays that this Honorable Court find his Application for Reinstatement to the Practice of Law to be well taken and grant that Application.
