MOTION TO SUPPLEMENT THE RECORD

Pursuant to S. Ct.Prac.R. 15.08, Plaintiff-Appellant, Board of Health of Cuyahoga County (“the BOH”) moves this Court for an order directing that the record be supplemented with the CD “containing twelve (12) files of records pertaining to lead assessment investigations which records are the subject of the ***action,” filed under seal in the trial court on October 19, 2012.
