

Respondent Cincinnati Public School District ("CPS") and Relator School Choice Ohio, Inc. ("School Choice") jointly move for a stay of the above-captioned case against CPS. School Choice and CPS have agreed to a settlement agreement which resolves all of the claims against CPS. The claims in the Complaint against Respondent Springfield City School District are not affected by the settlement and will proceed.

The deadline for CPS to file an answer to the Complaint is September 2, 2014. CPS filed a stipulated extension of time to answer on August 8, 2014. To avoid unnecessary time and expense of preparing an answer (regarding claims that are now resolved), CPS and School Choice respectfully request the Court to grant a stay of the case against CPS, and specifically to excuse CPS from filing an answer by September 2, 2014. CPS and School Choice anticipate that a dismissal of claims against CPS will be filed within 45 days.


