

**STIPULATION FOR EXTENSION OF TIME TO FILE THE SECOND MERIT  
BRIEF OF APPELLEE/CROSS-APPELLANT  
THE OFFICE OF THE OHIO CONSUMERS' COUNSEL**

Counsel for Appellee and Cross-Appellant, the Office of the Ohio Consumers' Counsel ("OCC"), Appellants and Cross-Appellees Ohio Edison Company, Appellee and Cross-Appellant Environmental Law and Policy Center, and Appellee-Public Utilities Commission of Ohio stipulate to a (20) twenty-day extension of time for the filing of OCC's Second Merit Brief, pursuant to S.Ct.Prac.R. 3.03(B)(2)(a)(i). OCC has not previously obtained an extension of time under S.Ct.Prac.R. 3.03(B)(2)(a)(i).

OCC's Second Merit Brief is currently due on October 3, 2014.<sup>1</sup> Twenty days after October 3, 2014, is Thursday, October 23, 2014. Accordingly, the new date for the filing of all Second Merit Briefs agreed to by the parties is October 23, 2014.<sup>2</sup>
