Dear Ms. Kolenich:

On August 22, 2012, in *Disciplinary Counsel v. Erika Howland Klie Kolenich*, the Supreme Court of Ohio imposed reciprocal discipline upon you after you were disciplined by the state of West Virginia. This court ordered that you be publicly reprimanded and further ordered you to complete nine hours of continuing legal education in law office management. In addition, it was also ordered that you complete a two-year monitored probation in accordance with Gov.Bar R. V(9) that would be satisfied by your compliance with the West Virginia Agreement with Supervising Attorney. The court also ordered that your probation would not be terminated until such time as your probation has been terminated in the state of West Virginia.

On September 9, 2014, you filed an application for termination of probation with this court. The Supreme Court of Ohio has informed the clerk's office that it will not consider an application for termination of probation until the attorney has complied with the court's orders and Rules for the Government of the Bar of Ohio. The court's suspension order required you to complete nine hours of continuing legal education in law office management. In a letter filed with the court on October 16, 2014, the Office of Attorney Services indicates that since August 22, 2012, you have reported completing five approved CLE activities for a total of 42.50 CLE credits. I have reviewed the course information for these activities and, upon my review, have determined that you have only completed 3.6 hours related to law office management.

If you believe the information provided by the Office of Attorney Services is inaccurate, please contact that office to resolve the matter. You may file additional documentation to support your compliance with this portion of the court's order. Note

that all documents filed with the court in this case must meet the filing requirements set forth in the Rules of Practice of the Supreme Court of Ohio.
