


**NOTICE OF APPEAL OF APPELLANTS**  
**JESSICA SIMPKINS AND GENE SIMPKINS**

Appellants Jessica Simpkins and Gene Simpkins hereby give notice of appeal to the Supreme Court of Ohio, pursuant to Ohio Supreme Court Rule 7.01, from the judgment of the Delaware County Court of Appeals, Fifth Appellate District, captioned *Simpkins v. Grace Brethren Church of Delaware*, No. 13 CAE 10 0073, entered and journalized on August 8, 2014. A timely application for reconsideration was filed on August 18, 2014 by Appellee Grace Brethren Church of Delaware, Ohio. The Fifth District denied the application and journalized that decision by a Judgment Entry dated September 30, 2014.

Date-stamped copies of the Fifth District Court of Appeals August 8, 2014 Opinion, August 8, 2014 Judgment Entry and September 30, 2014 Judgment Entry denying reconsideration are attached as Exhibits 1, 2 and 3, respectively, to the Appellants' Memorandum in Support of Jurisdiction.

For the reasons set forth in the accompanying Memorandum in Support of Jurisdiction, this case raises a substantial constitutional question and is one of public or great general interest.


