RELATOR'S NOTICE OF CORRECTION TO ITS MOTION
FOR AN IMMEDIATE INTERIM REMEDIAL SUSPENSION
UNDER GOV. BAR R. V(5a)

Relator hereby notifies the parties and the Court of an inadvertent error in its Motion for an Immediate Interim Remedial Suspension, which was filed with the Court on November 4, 2014. This Notice is provided upon relator becoming aware of the error and prior to respondent's deadline to respond. The word "almost" was omitted from the first sentence of the second paragraph on page five of relator's Motion. That sentence should read: "Another defendant, after being convicted of DUI for the first time, was *almost* terminated from her nursing school program because respondent required her to make multiple eight-hour courtroom appearances in connection with her effort to have her driving privileges restored." The citation to that fact, Exhibit 2, paragraph 30d of the Affidavit of Judge Ronald Bruce Adrine, is correctly set forth in the Motion. In order to avoid a misstatement of that testimony, relator submits this correction.
