


Relator Judicial Notice

I, Amirah Sulataana, the undersigned affiants and make this affidavit of my own free will and hereby affirm under oath, sworn that the information in this affidavit is true, and correct and certify from my personal knowledge the following to be accurate and was communicated / observed. It is my duty, obligation, and intent to give accurate statements (I am a law abiding citizen).

- 1. I am Owner/Chef of the No. 1 Vegan/Healthy Restaurant in Cleveland, Ohio (Pure & Supreme Cuisine located downtown Cleveland.)**
- 2. I have studied & taken courses through many Colleges & University (Major Business, Psychology, Communication, Healthy Foods, etc)**
- 3. I have worked/employed with IRS for 4 years and with AT&T for 34 years, etc.**
- 4. Regarding Supreme Court case No. 14-1855.**
- 5. Starting from getting a copy of the records (trial court case no. 13-571616) for the Appeal. The court reporter stressed & informed "he was informed/ and obligated to send the entire record to the Eighth District Court of Appeals".**
- 6. After receiving Record, discovered Jury Verdict Forms were not included (missing) which Hakeem Sulataana have been requesting/demanding, needing for himself for review to gain access to which he has been disputing and is aware Assignment of Errors can be made from for Appeal purpose.**
- 7. Over a period of time, since September, 2014, until present/currentI have made numerous phone calls and visits to the Cleveland Clerk of Courts (criminal Division) and the Clerk of Courts (Certified Division) /both under Andrea F. Rocco to request a copy of Jury Verdict Forms and have spoken with on different occasions a total of eight (8) different Clerks from the court (names available upon request) from both units and would get the same answer/response in different words/same meaning "There is No Image to print out to provide Jury Verdict Forms" . The Trial Court never filed Jury Verdict Forms with Clerk of Courts. They do not have access to a Image to print out a copy of Jury Verdict Forms to provide / never had one. There is none and do not have privilege to Jury Verdict Forms. The Judge / Baliff / or Upstairs never sent down from up stairs even though they should of " To Record / Document ", but not.**

This has been a practice. Because I was adamant about obtaining one and getting to the bottom of missing Jury Verdict Forms issue in one instance / occasion one of the Clerks turned the computer around for me to see with my own eyes to review the docket screen for the 4-8-2014 typed note S “there is no image” (exhibit A), on other lines around 4-8-2014 with different docket info “clicked on and opened up other icons where there was a image for view = still no Jury Verdict Forms” to prove/show “there is no Jury Verdict Forms for this case” and to inform to speak with Certified Division (which there was previous researched on many occasions & even with a call back on the next day/ along with current research the same information “No Jury Verdict Forms” and to speak with the Judge Bailiff presiding over this case (13-571616). From the Clerks of Courts, I was informed the 4-8-2014 date on docket show Jury Verdict Forms was “it is just a typed note that was electronically batched down from the Judge office (Type = OT (mean other, VERD, D1 (mean Defendant) which mean Jury Verdict Form was filed other than the Defendant which was electronically batched down on docket (exhibit B). I spoke with Judge Peter J. Corrigan Bailiff and was informed to speak with Hakeem Sulataana counsel.

8. On November, 10th, 2014, counsel, Erika Cunliffe, filed with the Eighth District Court of Appeals, “Motion to Supplement the Record on Appeal” and made erroneous statements that Hakeem Sulataana ask that those Jury Verdict Forms be filed under seal and “having communicating with the Clerk of Courts it is undersigned counsel understanding that those Jury Verdict Forms have been scanned by the Clerk’s Office and are available to this court” (exhibit C”. That night, via a voice mail left message, I communicated “it would be impossible for Clerk to supply you the Jury Verdict Forms (giving detailed information) they were never received, never imaged, never scanned to forward that is considered Malpractice to have documented those statements (to make falsified statements) when everyone is in agreement in the Clerk of Courts office is adamantly “there is and never was any Jury Verdict Forms filed with the Clerk of Courts” “They are kept upstairs and always have been!!!”

9. Per Hakeem Sulataana, he requested/demanded & I asked Counsel “not to go forward with this word game / hoax when there is no actual Jury Verdict Forms (and if there is “it must be an Original and not scanned) and not to submit any more Motions with falsified information and not to help his Appeal and not to file any additional Motions about she have possession of “Original Jury Verdict Form” without him having a copy of which is a rule/law pursuant to R.C. 149.32 and if Clerk of Courts would of have received

(it would have a stamped filed date and no. (ex. JR.4781 ___). Counsel, Erika Cunliffe, returned call to me following day, and made statement "she is going forward with this" and made statement during the course of our conversation "the Judge asked her to file Motion for Jury Verdict Form to be under seal", I then asked if Hakeem Sultaana, will be getting a copy of this Jury Verdict Form (she proclaim to have possession of) initially, she said he would receive a copy for view. That changed, she informed "that decision will be left up to the Judge" and he can file for a request pro se. I brought to her attention, why don't you submit request since you are his counsel and recently you said you have copy and he'll get one. Regarding pro se, where as you yourself know and aware and informed me "anything he submit to the Eighth District Court of Appeals would be denied, dismiss & not acknowledged and no one is even looking at his filing / not taking him serious. On 11/12/2014 Hakeem Sultaana filed at the Eighth District Court of Appeals his object to purported scanned Jury Verdict Form with objection to filing under seal. (Exhibit D)"

10. I cited C.R. 149.32 that Jury Verdict Forms is Public information and when there is a request to under seal Jury Verdict Forms it is generally via the state, are you the State? Are you working with the State? It appears you're working against him / not helping. Our last conversation was "you were going to request Motion to leave to Supplement his assignment of errors, you didn't But, come up with this under seal game. Recently, you said you would provide him with a copy of the Jury Verdict Form, initially you said it is going to be difficult / an issue because they have been shredded the Judge department have a habit of this and have been practicing this procedure for quite some time and the Public Defender Office have been on them about this practice, next you informed they are no where to be found, then you say the Clerk scanned them (from where?) 3 different stories.
