MEMORANDUM IN SUPPORT

On March 4, 2014, the Defendant, Ariel Reidenbach, entered a plea of no contest to one (1) count of Petty Theft. Ms. Reidenbach was sentenced by Judge Angela R. Stokes to pay a fine of one thousand dollars (\$1,000.00), which was suspended, one hundred and eighty (180) days of incarceration, which was suspended, and to one (1) year of active probation. Judge Stokes imposed a variety of conditions on Ms. Reidenbach's probation, as evidenced by the attached docket entries dated March 4, 2014.

On April 9, 2014, Ms. Reidenbach was found to be in violation of her probation. Judge Ronald B. Adrine indicated that the terms of Ms. Reidenbach's probation were to continue until the original end date, but that no further judicial updates were required absent allegation of probation violation.

Ms. Reidenbach now petitions the Court to transfer her probation to Fort Gay, West Virginia for the remaining period of supervision. Ms. Reidenbach is not a native resident of Northeast Ohio, and hopes to return home to Fort Gay, West Virginia in order to disassociate herself with the people and locations connected with her substance abuse issues and become a productive and law-abiding member of society.


WHEREFORE, Defendant, Ariel Reidenbach, respectfully requests that the probation period under this sentence be transferred to the above-referenced jurisdiction.

Responsibility for the disposition of the above captioned case is hereby transferred from the docket of the Honorable Angela R. Stokes to the Administrative Judge of the Cleveland Municipal Court, pending status review and/or temporary reassignment. Said transfer and temporary reassignment will only be in effect during the pendency of the certified complaint filed against Judge Stokes with the Supreme Court's Board of Commissioners on Grievances and Discipline on October 14, 2013, unless the case is otherwise resolved in the interim. The transfer is made pursuant to authority granted under Sup. R. 4(B) and Sup. R. 4(B)(1), and in order to maintain and enhance public confidence in the legal system (Paragraph 1, Preamble, Code of Judicial Conduct).

The transfer is justified for the following reasons:

- A certified complaint pending against Judge Stokes before the Ohio Supreme Court's Board of Commissioners on Grievances and Discipline was gleaned from approximately 337 alleged violations of the Code of Judicial Conduct presented to the Cleveland Municipal Court.
- All of those allegations concerned her mishandling of criminal matters and mistreatment of participants in criminal hearings, including defendants, witnesses, police officers, prosecutors, private defense counsel, public defenders, court personnel and other members of the general public.
- Since the original complaint was presented to the Disciplinary Counsel, and continuing through and after the complaint's certification by the Board, nearly 100 additional written incident reports have been received by this office alleging similar problems involving the Judge's handling of her personal criminal docket.
- The court continues to receive, on average, one to two new ethics complaints against Judge Stokes per week.

Ms. Reidenbach stated that when she was five years old she was molested by her older brother's father. Ms. Reidenbach attended Lincoln West High School and dropped out in the 9th grade. Ms. Reidenbach stated that she's experienced a great deal of hard times in her life, which has ultimately led to her experiencing continual thoughts of suicide especially when she's stressed or pressured. Ms. Reidenbach stated that she has attempted suicide two times in her life and identified herself as a "Cutter". The most recent being three months ago when she used a screw driver and dug into the skin located between her hips and private area. Ms. Reidenbach stated that a couple of years ago her brother sold crack/cocaine and she would help him sell it. The defendant stated that her life became more chaotic which is what led to her using the drug instead of selling it. Ms. Reidenbach stated she uses crack/cocaine as a means handling unwanted pressures. Ms. Reidenbach stated she uses drugs on a weekly to bi-weekly basis. The defendant viewed herself as having abandonment issues; has never been in counseling or drug treatment and is expressing a desire for help.

On 2/18/14, Ariel Reidenbach appeared before the Honorable Judge Stokes and was found guilty of: Petty Theft. The defendant was referred to the Probation Department for a Pre-Sentencing Investigation with the stipulation that Ms. Reidenbach submit to a Urinalysis test on today's date which would be paid by the court.
