

Dear Ms. O'Toole:

On October 24, 2012, the five-judge commission appointed in this matter instructed you "to pay attorney fees in the amount of \$2,500 by cashier's check or money order payable to Mary L. Cibella, 614 West Superior Ave., Ste. 1300, Cleveland, Ohio 44113 on or before November 15, 2012, and provide proof of payment to the Clerk of Court." The Supreme Court of Ohio subsequently stayed the payment of these attorney fees pending the disposition of your appeal of the commission's order. On September 24, 2014, the Court ruled on your appeal and ordered you to pay "attorney fees in the amount of \$2,500.00 which were imposed by the five-judge commission" within thirty days.

On October 24, 2014, you submitted payment totaling \$6,030.82 to the Court. This amount included payment of the attorney fees in the amount of \$2,500.00. The attorney fees, however, were to be paid to Ms. Cibella, not the Court. Enclosed please find a check in the amount of \$2,500.00, which represents the attorney fees that you erroneously paid to the Court. Please submit payment to Ms. Cibella as previously ordered and file proof of payment with the Clerk's Office within fourteen days of the date of this letter.




