

**STIPULATION TO EXTENSION OF TIME  
FOR FILING OF MERIT BRIEF**

---

On December 9, 2014, the Appellee, the Public Utilities Commission of Ohio (“Commission”), filed a stipulated request for an extension of time to file its merit brief in this case, resulting in a new deadline for that merit brief of **January 27, 2015**. Intervening Appellee, Duke Energy Ohio, Inc. (Duke Energy Ohio) must file its merit brief in this case on the same date as the Commission. *See* S.Ct.Prac.R. 3.03(B)(3).

Pursuant to S.Ct.Prac.R. 3.03(B)(2)(a)(ii), counsel for Interstate Gas Supply, Inc.; the Commission; and Duke Energy Ohio have agreed that Duke Energy Ohio may extend its merit brief filing deadline by twenty days. Furthermore, as the date so extended under this agreement would fall on a legal holiday, pursuant to S.Ct.Prac.R. 3.03(A)(1), the new deadline for Duke Energy Ohio and the Commission to file their respective merit briefs is **February 17, 2015**. Duke Energy Ohio has not requested a prior extension in this case.

This stipulation will also extend Interstate Gas Supply’s deadline to file a reply brief, which will now be twenty days (20) from the date the Commission and Duke Energy Ohio file their merit briefs. *See* S.Ct.Prac.R. 16.04(A)(2).
