OF RESPONDENT JOHN DANIEL MISMAS**


Now comes the applicant, John D. Mismas, by and through counsel and hereby supplements his Application for reinstatement filed December 15, 2014. On January 20, 2015 the Clerk of Court sent Mr. Mismas correspondence stating in relevant part:

On June 12, 2014, the court suspended you from the practice of law for a period of one year with six months stayed on the conditions that you (1) engage in no further misconduct, and (2) **continue to comply with all recommendations of your treating medical and psychological professionals.** On December 15, 2014, you filed an application for reinstatement. The Supreme Court of Ohio has informed the clerk's office that it will not consider an application for reinstatement until the attorney has complied with the court's orders and Rules for the Government of the Bar of Ohio.

The court's suspension order required you to comply with all recommendations of your treating medical and psychological professionals. **Please submit proof that you have fulfilled this requirement.** (Emphasis added.)

Attached herewith is an affidavit from Applicant's treating psychologist, Marilyn Wise, confirming Mr. Mismas has complied with her recommendations and the Court's Order of June 12, 2014 as requested by the Clerk's January 20, 2015 correspondence.

recommendations during his treatment.


