
## NOTICE OF APPEAL

Plaintiff-Appellant James E. Pietrangelo, II hereby gives notice of appeal to the Supreme Court of Ohio from the October 23, 2014 judgment (journal entry) of the Lorain County Court of Appeals, Ninth Appellate District, in Court of Appeals case No. 14CA010644, Pietrangelo v. City of Avon Lake, Ohio, dismissing Pietrangelo's August 25, 2014 appeal for lack of a final, appealable order. This case raises a substantial constitutional question and is one of public or great general interest.

On October 31, 2014, Pietrangelo timely filed an application for both panel reconsideration and reconsideration *en banc* of the panel's October 23, 2014 judgment. On January 15, 2015, both applications were denied. To the extent necessary, Pietrangelo hereby appeals these denials as well, as with the original October 23, 2014 judgment.
