
**RELATOR’S NOTICE OF APPOINTMENT
OF MONITORING ATTORNEY**

By Order filed February 10, 2015, the Supreme Court of Ohio suspended Respondent Jennifer Ann Gorby from the practice of law in the State of Ohio for a period of one year with the entire suspension stayed on the conditions that (1) she engage in no further misconduct; and (2) she submit to a one-year period of monitored probation focusing on law-office and trust-account management.
