AFFIDAVIT OF RESPONDENT LUMUMBA TOURE' McCORD

1. I am the Respondent in the above matter. I have personal knowledge of my compliance with the Supreme Court's Order of December 10, 2014.

2. I have not counseled, advised or prepared any legal instruments for others or in any manner performed any legal services for another since December 10, 2014.

CONTINUING LEGAL EDUCATION COMPLIANCE

3. I have complied with the Gov.Bar R. X(13) by completing at least one credit hour of continuing legal education for each month, or portion of a month of the suspension.

4. Between February 19 and 21, 2015, I completed 14.00 hours of continuing legal education, which included one hour of ethics. See Exhibit A, certificate of completion of CLE from NACDL.

5. NACDL confirmed that it reported my CLE to the Supreme Court of Ohio.

CLIENTS' SECURITY FUND

6. No funds were awarded by the Clients' Security Fund in this matter.

CLIENT NOTIFICATION

7. All clients were notified of my suspension from the practice of law.
8. The Franklin County Court of Common Pleas re-assigned all of my court appointed cases to other counsel on December 10, 2014.
9. On December 10, 2014, I had 6 private clients. These clients were immediately notified by text message that I was suspended and given referrals to alternate counsel.
10. As directed by the clients, any flat fees were immediately transferred to new counsel, along with any files.
11. In December 2014, I handled only criminal cases in Franklin County Court of Common Pleas. The Supreme Court notified the Franklin County Court of Common Pleas via email of my suspension on December 10, 2014.
12. On December 10, 2014, the Franklin County Court of Common Pleas withdrew my e-filing privileges and would not accept any notices of withdrawal from me.
13. All my court-appointed cases transferred
14. Order of the Franklin County Court of Common Pleas. This transfer placed the prosecutors on notice of new counsel through the e-filing system.
15. All privately retained cases were transferred to subsequent counsel, who entered appearances for the defendants.
16. I sent certified mail notices to all privately retained clients on March 10, 2015, in addition to the December text message notices. Exhibit B, Copies of notices with client names and addresses redacted.
17. All former clients knew my cell phone and office address to contact me if information needed to be forwarded to new counsel.
