




Now comes, Defendant-Appellant Schuyler Smith with Affidavit to Disqualify Chief Justice Maureen O'Connor from case no. 2014-0672, of Supreme Court of Ohio, for reasons below.

The Rights of Defendant-Appellant Schuyler Smith have been violated throughout the entire proceedings of case no. CV2013 01 0297, CA2013 12 0237, and Supreme Court case 2014-0672.
