
Dear Ms. Ferguson:



Lumumba Toure' McCord (Attorney Registration No. 0066968) filed a motion for reinstatement with this court on March 19, 2015. According to the court's order dated December 10, 2014, Mr. McCord was suspended from the practice of law under an interim default suspension. On March 6, 2015, the court ordered that Mr. McCord's interim default suspension shall terminate upon the filing of his answer with the Board of Professional Conduct. The court further ordered that Mr. McCord shall not be reinstated until he files proof of his compliance with Gov.Bar R. X(13).

Could you please inform me whether Mr. McCord has received any credit for continuing legal education hours since December 10, 2014? I would appreciate it if you would also inform me if any of the CLE hours related to professional conduct.
