MEMORANDUM

This Court issued an Order to Show Cause in this matter on February 26, 2015. This order permits the parties until March 18, 2015 to submit objections to the findings of fact and recommendation of the board, along with briefs in support, and provides Relator 15 days to respond. Relator seeks additional time to submit their Response.

Pursuant to S.Ct.Prac.R. 3.03(B)(2)(a)(i), the parties have stipulated to a nine (9) day enlargement of time, moving Relator's deadline to file a response to Respondent's objections and merit brief from April 22, 2015 (15 days after the objections were actually filed) to May 1, 2015.
