**RELATOR’S REPORT REGARDING RESPONDENT’S
COMPLIANCE WITH MONITORING**

I. Introduction

On August 29, 2012, this Court issued an order suspending respondent, Christopher James Burchinal, from the practice of law for two years with the final twelve months stayed on conditions. The Court further ordered, among other things, that respondent serve an eighteen-month monitored probation upon reinstatement. Respondent was reinstated to the practice of law by order dated April 11, 2013. Relator now files its report regarding respondent’s compliance with the terms of probation.

II. Relator’s Report


Pursuant to this Court’s April 11, 2013 order, relator supervised respondent’s eighteen-month probation and, under Gov. Bar R. V(21), appointed Attorney Thomas C. Clark as respondent’s monitoring attorney. Clark submitted six quarterly reports regarding respondent’s compliance with the conditions of his probation. Each report indicated that respondent was in full compliance with the terms of his probation. OLAP has confirmed that respondent is in compliance with his OLAP contract. Relator has not learned of any probation violation during

respondent's eighteen-month probation. Further, relator's review of the reports submitted by Clark indicates that Clark fully complied with his duties as the monitoring attorney.


III. Conclusion


