

NOTICE OF APPEAL OF PLAINTIFF-APPELLANT STATE OF OHIO

Plaintiff-appellant, the State of Ohio, hereby gives notice of appeal to the Supreme Court of Ohio from the judgment of the Franklin County Court of Appeals, Tenth Appellate District, entered in *State v. Ibrahim*, 10th Dist. No. 14AP-355, on November 28, 2014, and from the journal entry entered in the same case on November 28, 2014.

This appeal is being timely filed pursuant to S.Ct.Prac.R. 7.01(A)(5). The State filed a timely application for reconsideration in the Tenth District on December 5, 2014, and the Tenth District dismissed that application by decision and journal entry filed on March 31, 2015.

Because new errors arose in the March 31, 2015 decision and journal entry, the State's appeal here is also timely in relation to that decision and journal entry as well.

The State of Ohio invokes the jurisdiction of the Supreme Court on the grounds that the case presents questions of public or great general interest, and involves a felony and warrants the granting of leave to appeal.


