LIMITED OBJECTION TO FINDINGS OF FACT

Now comes Co-Relator, Warren County Bar Association (Warren County) and hereby submits its limited objection to the findings of fact for the sole purpose of correcting the Record.


In the Findings of Fact, Conclusions of Law, and Recommendation of the Board of Professional Conduct of the Supreme Court of Ohio, the Board found that Warren County did not recommend a specific sanction. *See* p. 13, ¶ 56.

Warren County asks that the record be corrected to reflect that Warren County recommended a sanction of two years, with one year stayed conditioned upon Respondent being compliant with: i) the three (3) year OLAP contract; and, ii) continuous mental health counseling with a licensed psychologist for the term of the OLAP contract. *See* Post Hearing Brief of Warren County Bar Association, p. 10.

Nothing in this limited objection should be construed as requesting a hearing, and Warren County waives an oral argument.


