

I certify that I have emailed a copy of this memorandum to Disciplinary Counsel for the State of Ohio **this** 27th day of April, 2015 (Emphasis added).


Respondent's certificate of service proves that he provided a copy of the pleading to relator three days *before* he filed it. Consequently, relator had no way of knowing that respondent actually filed the pleading. Fortuitously, relator checked the Court's online docket on May 12, 2015 and noticed—for the first time—that respondent had filed his Objections. On May 12, 2015 relator e-mailed respondent requesting that he consent to a 20-day extension, but respondent failed to reply. On May 13, 2015, relator's assistant contacted respondent by telephone; however, respondent refused to consent to the 20-day extension and hung up the phone on relator's assistant.

Respondent's improper service provides good cause for this Court to grant relator's request for a 10-day extension of time under S. Ct. Prac. R. 3.03(B)(2)(i) to May 25, 2015. Finally, relator's request is in no way intended to delay these proceedings.


