On May 5, 2015, the Merit Brief of Intervening Respondent/Appellant S.F. was filed in this case. Pursuant to S.Ct.Prac.R. 16.03(A)(2), the Merit Brief of Respondents/Appellees Cuyahoga County Court of Common Pleas, Juvenile Division, and The Honorable Alison L. Floyd (hereafter “the Juvenile Court Appellees”) is currently due by June 4, 2015.

Pursuant to S.Ct.Prac.R. 3.03(B)(2)(a), counsel for Appellant and counsel for the Juvenile Court Appellees hereby stipulate that the Juvenile Court Appellees shall have an extension of time of twenty (20) days, up to and including June 24, 2015, within which to file the Merit Brief of the Juvenile Court Appellees.

This extension is being filed within the time prescribed by the Supreme Court Rules of Practice for filing the brief that is the subject of the stipulation. This is the only stipulated extension of time obtained by the Juvenile Court Appellees in this case, and they have not

previously obtained an extension of time from the Supreme Court under S.Ct.Prac.R.

3.03(B)(2)(b).

In accordance with this stipulated extension of time, the Merit Brief of the Juvenile Court Appellees shall be filed no later than June 24, 2015.
