


The Appellee property owners file this stipulation of extension of time to file its merit brief pursuant to S.Ct.Prac.R. 3.03(B).


The appellees' brief was due May 27, 2015. The new due date is June 16, 2015.


Counsel for the Board of Education, Counsel for the County Appellees, and Counsel for the Tax Commissioner have given their consent in writing.




