MOTION OF ATTORNEY MARSHA L. LEVICK FOR PERMISSION TO APPEAR

PRO HAC VICE

Pursuant to Gov. Bar R. XII and S.Ct.Prac.R. 2.02, Marsha Levick, counsel for *amici curiae* Juvenile Law Center, Center on Wrongful Convictions of Youth, Bluhm Legal Clinic at Northwestern University School of Law, Children’s Law Center, Inc. of Kentucky, and the National Juvenile Defender Center hereby moves the Supreme Court of the State of Ohio to grant her permission to appear *pro hac vice* and participate as *amici* in support of Appellant Tyshawn Barker.


