MEMORANDUM


This disciplinary matter first came before the court as a certification of the Respondent's Default under Board of Commissioners for Grievances and Discipline Case No. 2012-093. On October 11, 2013, William B. Strubbe – undersigned counsel- filed a notice of appearance under the instant caption, along with a stipulation of time to file objections and a brief in support. Following the filing of objections and a brief in support, on November 4, 2013,

the case was remanded to the Board on December 17, 2013. Strubbe has not appeared or filed pleadings on behalf of Respondent in this court since November 4, 2013.

Strubbe was granted leave to withdraw as counsel for Respondent under Board of Commissioners for Grievances and Discipline Case no. 2012-093 on August 6, 2014. A copy of that order is attached as Exhibit "A". At the time of that withdrawal, the Board had jurisdiction. Since that date, Counsel has not made any appearances or submitted any pleadings on respondent's behalf before either the Board or this Court. All subsequent communications of substance in this matter on behalf of the Court have been with Respondent directly.

Strubbe was referred to as Counsel of Record for Respondent in the Slip Opinion ordering Respondent's suspension. This is inaccurate, as he had been permitted to withdraw as her attorney, and had done nothing in her behalf since the withdrawal.



