## MOTION

It has come to Appellant's attention that a typographical error was made in the "certified question" before this Court – an error that originated in the court of appeal's decision and entry filed January 20, 2015, and which was repeated, ultimately, in this Court's Entry, filed April 29, 2015, determining that a conflict exists. The typographical error relates to the citation to one of the revised code sections at issue.

The question as originally stated reads as follows:

"Once an adult court determines under R.C. 2152.52(B)(4) that at least one charge for which the juvenile was convicted is subject to mandatory transfer, is that court permitted to sentence the juvenile under R.C. Chapter 2929 on all charges in the case, or must the adult court complete a separate analysis under R.C. 2152.121(B) for each charge individually?"

The question should instead read as follows:

"Once an adult court determines under **R.C. 2152.121(B)(4)** that at least one charge for which the juvenile was convicted is subject to mandatory transfer, is that court permitted to sentence the juvenile under R.C. Chapter 2929 on all charges in the case, or must the adult court complete a separate analysis under R.C. 2152.121(B) for each charge individually?"
