

7) As one of the four counsels of record for Relator assigned to the case by the Chair of the Committee, I can attest that I received no copy of Respondent's Objections by "hand delivery" at the CBA offices or otherwise on May 8, 2015 or anytime thereafter.

8) The other three counsel of record for Relator, Jeffrey C. Rogers (0069399), James P. Tyack (0072945), and Al Alysha Clous, (00706672) have informed me that they also did not receive a copy or notice of Respondent's Objections.

9) Relator's counsel were unaware of the filing of the Objections until on or about May 26, 2015, when a Committee member happened to look at the Court's docket and saw that the Respondent's Objections had been filed several weeks previous.

10) On May 27, 2015, I attempted to phone Respondent at the number he lists in his registration with the Court, 614-449-1124 but found the number had been "disconnected."

11) On the same day, I prepared a fax message to Respondent asking him to call Relator's counsel immediately to explain what, if any, attempt he had made to serve Relator with the Objections.

12) The fax did not go through, so the same day I hand delivered a copy of it to his office at 713 South Front St. Columbus, OH. A secretary received it and said she would put it on his desk chair.

13) I also had staff check the visitor's sign-in list maintained in the lobby of the building which houses the CBA on either May 7th or 8th. There was no evidence that Respondent had signed in (as required) to come up to the Columbus Bar Association offices on those days.

14) Having heard nothing from Respondent, on June 2, 2015, I prepared a second message to Respondent indicating that, if Relator did not hear from him we would file to have the Objections dismissed for failure of service. I hand delivered this message to his office. The

same secretary received it and said she would contact Respondent by phone to tell him he had a message from me. She also told me she knew he had received the first message.

15) Also on June 2, 2015, I hand delivered another copy of the second message to Respondent's home address and affixed it to his front door. A neighbor confirmed to me that Respondent does live in that home.
