The Order grants me up to twenty (20) days from the date of the order (dated August 6, 2015) to show cause why I should not be found in contempt for failure to fully comply with this court's order of June 25, 2015, to wit: failure to file an affidavit of compliance on or before July 27, 2015.


I attempted to file such affidavit a few days late, explaining that I failed to send notice to my remaining clients via certified mail. I had contact each of them via either e-mail or phone, and each of them had chosen to retain their representation with my co-counsel, Andrew Green. However, it was my mistake not to communicate the required information to those clients via certified mail, as required by the Order.

I corrected that mistake, and then filed the Affidavit, reflecting the correction in that notice mistake. However, the Affidavit was rejected by the court staff, as you will see in the attached Affidavit and response from the court staff. I am re-submitting the Affidavit for re-filing with this Court.



