


RESPONDENT'S RESPONSE TO ORDER TO SHOW CAUSE

Angela Maries Whitt ("Respondent") hereby file their response to this Court's September 25, 2015 Order to Show Cause "why respondent should not be found in contempt for failure to fully comply with this court's order of July 24, 2015, to wit: failure to file an affidavit of compliance on or before August 24, 2015" and respectfully state as follows:

1. The Respondent's failure to timely submit an Affidavit of Compliance was not the result of intentional delay and should not result in the finding of contempt.
2. The court's order of July 24, 2015 was sent while Respondent was incarcerated and unable to directly accept the order. Respondent's husband signed for the certified mail.
3. At the time Respondent's husband signed for the certified mail, he was suffering the effects of a concussion from an automobile accident that occurred July 11, 2015, including short term memory loss, mild confusion, and an exacerbation of his multiple sclerosis. A letter from his physician is enclosed.
4. Due to the Respondent's husband's condition, the court's order was not communicated or given to the Respondent, resulting in the Respondent's lack of

knowledge of such an order.



5. Upon Respondent's early release from incarceration, Respondent promptly filed for inactive law license status and additionally received a Letter of Inquiry from Disciplinary Counsel on August 20, 2015 but that Letter did not indicate any requirement to file an affidavit of compliance.
6. Upon receipt of court's Order to Show Cause, Respondent made inquiries regarding the court's order from July 24, 2015 and will file the required affidavit of compliance immediately.
7. Additionally, Respondent has not practiced law since 2014, does not have any clients or trust accounts to notify, and has paid all restitution and court costs as required.

WHEREFORE, Respondent respectfully request's that the Court refrain from finding Respondent in contempt.
