Relator, Ohio State Bar Association, hereby submits its report regarding Respondent's compliance with the monitoring ordered by this Court on September 15, 2014.


Relator's Report

By its order of October 13, 2009, the Court suspended Respondent from the practice of law for one year, with six months stayed on condition. By its order of November 27, 2012, the Court suspended Respondent from the practice of law for a period of two years, with one year stayed on conditions. By its order of September 14, 2014, the Court reinstated Respondent to the practice of law. The order further provided that Respondent be placed on probation for a period of one year in accordance with Gov. Bar R. V(9).

Pursuant to the Court's order, Relator appointed Earl Williams, Jr. (0006975) as Respondent's monitor. Mr. Williams was requested to submit, and did submit, quarterly reports concerning his monitoring of Respondent. Mr. Williams reported that Respondent met with him as required and was fully cooperative.

Respondent has fully complied with the terms of his probation.
