NOTICE

On October 21, 2015, Petitioners Stanley M. Chesley and Waite, Schneider, Bayless & Chesley Co., LPA filed a joint Partial Voluntary Dismissal Without Prejudice in Hamilton C.P. No. A1500067. (A certified copy of this filing is attached as Exhibit A). Pursuant to Ohio Rule of Civil Procedure 41 (A)(1)(a) the petitioners agreed to “voluntarily dismiss without prejudice all claims in this matter pending against Respondent Angela M. Ford, only.”

There is only one Relator in the matter pending before this Court, Angela A. Ford, Esq. As evidenced by the attached motion, Ford has been dismissed from the underlying lawsuit that gave rise to the Complaint in this case. (Exhibit A). Ford’s Complaint and requested writs are directly related to Ruehlman’s actions, and possible future actions, against Ford in *Chesley v. Ford*, Hamilton C.P. No. A1500067. As Ford is no longer a party in the underlying lawsuit, she has no right to request an extraordinary writ against a Hamilton County Judge in a lawsuit to which she is not a party. Therefore the Respondent suggests that this case is now moot.


