MEMORANDUM IN SUPPORT OF NOTICE

On July 17, 2014, this Court indefinitely suspended Respondent Bridget M. McCafferty from the practice of law with no credit for time served under her pending interim felony suspension. Further, it ordered that the interim felony suspension in case No. 2011-1542 would continue until Respondent completed her federal supervised release and discharge by the federal district court; after that time, her indefinite suspension would begin to run.

Attached as exhibit A is a Notice of Discharge from the United States District Court for the Northern District of Ohio, U.S. Pretrial Services and Probation Office. It notes Respondent's sentence imposed on September 17, 2012 was successfully completed and expired on September 16, 2015. Respondent has been fully discharged from the supervision of the federal court since that time.
