


Enclosed is a copy of the continuing legal education record of David Edward Troller, attorney registration number 0013296 as of October 22, 2015 (Exhibit 1). A review of his record indicates that since January 14, 2014, he has reported completing thirty one (31) approved CLE activities for a total of 68.75 CLE credits. Of this amount, 16.5 hours were awarded for instruction in professional conduct.

A review of the records of the Office of Attorney Services indicates that Mr. Troller was suspended on May 16, 2006, for failing to comply with Gov. Bar R. X. On October 30, 2015, Mr. Troller submitted a petition for reinstatement in accordance with former Gov. Bar R. X (7), and has submitted the required documents necessary to reinstate him pursuant to Gov. Bar R. X.

A review of Mr. Troller's Attorney Registration record indicates that on December 2, 2005, Mr. Troller was suspended for failing to comply with Gov. Bar R. VI. On October 16, 2015, Mr. Troller filed an application for reinstatement, and has submitted the required documents necessary to reinstate and register him pursuant to Gov. Bar R. VI.
