Pursuant to S.Ct.Prac.R. 17.08, Relator the Cincinnati Bar Association hereby submits the following list of additional authorities that it may rely on during oral argument set for December 1, 2015:

Disciplinary Counsel v. Johnson, 104 Ohio St.3d 313, 2004-Ohio-6555, 819 N.E.2d 674 (finding that a pattern of misconduct with multiple offenses which ‘reflected a total disregard’ for the authority of courts and the administration of justice warranted permanent disbarment);

Cuyahoga Cty. Bar Assn. v. Wagner, 117 Ohio St.3d 456, 2008-Ohio-1200, 884 N.E.2d 1053 (finding that disbarment was appropriate in light of a pattern of misconduct, lack of cooperation with the disciplinary process, and Respondent’s refusal to acknowledge the wrongful nature of his conduct);

Cincinnati Bar Assn. v. Rothermel, 112 Ohio St.3d 443, 2007-Ohio-258, 860 N.E.2d 754 (finding that absent any mitigating circumstances, the penalty for ignoring orders of the court and continuing to practice law while under suspension is disbarment);

Disciplinary Counsel v. Fletcher, 135 Ohio St.3d 404, 2013-Ohio-1510, 987 N.E.2d 678 (imposing permanent disbarment where attorney failed to act with reasonable diligence in representing client, engaged in conduct prejudicial to the administration of justice, and continued to represent clients after his license was suspended); and

Cleveland Metropolitan Bar Assn. v. Brown, 143 Ohio St.3d 333, 2015-Ohio-2344, 37 N.E.3d 1199 (citing prior precedent, the Court accepted Board’s recommendation of permanent disbarment of attorney who continued to practice law while under suspension).
