


The undersigned being duly sworn, and pursuant to Order of the Supreme Court dated January 27, 2011, hereby states:

1. On the date of the Supreme Court's Order of Indefinite Suspension, I was employed by the Gallia County Public Defender's Office. All clients were indigent and counsel were chosen by said office. When I learned of the suspension, I contacted the head of the Public Defenders. Since, we were all aware that the suspension was imminent, we had already discussed my replacement and what to do when it happened. When the Order was issued, I gave all files to the Chair of the Defender's organization. Notices were given to all defendants and my replacement was given all my files and work product. The Court's were also prepared for the suspension and the subsequent substitution of counsel.
2. As indicated above, all documents, paperwork, files and work product were delivered to the Head of the Public Defender's Office and subsequently to the new attorney of record.
3. As indicated above, I was employed by the Public Defender's Office and received all compensation from that organization. To my knowledge, I had no other clients. There were no fees or expenses to refund.
4. Again, I was employed by the Public Defender's Office and all my cases involved either the City Solicitor or the Gallia County Prosecutor. Both of those offices were notified immediately. I had no civil cases and no opposing counsel other than the Prosecutor and Solicitor.
5. All notices required were transmitted by my employer, the Gallia County Public Defender's Office pursuant to their direction.
6. I am now filing with this Court the Affidavit required by the aforementioned Order.

7. I have retained whatever records I have of any and all steps taken pursuant to the Order.

I declare that, to the best of my knowledge and belief, the above information is true, complete and accurate.


