**JOINT STATUS REPORT

On October 15, 2015, the Court issued an Entry in this proceeding granting the parties' joint request for a stay of the briefing schedule. The Public Utilities Commission of Ohio (Commission) continues to consider options for moving forward with the net metering rule. On November 18, 2015, the Commission issued an Entry attaching a draft proposed net metering rule and directing interested persons to file comments by December 18, 2015 and reply comments by January 8, 2016. Although this appeal remains a live controversy, the draft proposed rule and stakeholder comment process shows the Commission's continued action on this matter. On that basis, the parties jointly request that the briefing stay be continued at this time and state that they intend to file another status report within sixty days of this filing.
